JOBS IN THE WOODS ACT

S.1336, H.R.4575

BACKGROUND

The forest products industry—including loggers and haulers, primary and secondary manufacturers, pulp and paper mills, and paper packaging facilities—is one of the largest manufacturing sectors in the United States. It sustains nearly 935,000 families and contributes \$435 billion annually to the national economy. Yet, mill labor shortages are limiting modernization and investment in existing and new facilities, while the logging workforce is aging rapidly. Fewer than one in four logging business owners are under 40; the average owner/operator is 55, and roughly 30 percent plan to leave the business within the next five years. Rural forest-based communities are also losing much of their next generation, with an estimated 40–60 percent of young adults leaving for other employment opportunities.

To address these challenges, regional forest industry training hubs would enable participants to remain in or near their communities, lowering costs and allowing curricula to be tailored to local needs through partnerships with area forest products employers. Targeted workforce education and training programs have been effective recruitment tools in computer programming, utility vegetation management, and the automotive industries.

The Jobs in the Woods Act would make this possible by creating a grant program for nonprofit organizations, state governments, and colleges to provide workforce training in forestry-related fields, preparing students for careers across the wood supply chain.

The Jobs in the Woods Act would:

- Establish a competitive grant program to make grants to eligible entities to carry out career pathway training programs in eligible areas with respect to forestry operations and forestry products industries.
- Create programs in rural and low-income areas to spur economic development, bringing thousands of dollars of investment into our rural communities.
- Create a pool of talented, trained, and qualified applicants to fill timber industry job openings, helping Americans obtain quality jobs to serve and responsibly manage our forests and secure our wood supply chain.
- Partner with programs that have proven to help students achieve forestry industry jobs and programs that engage with their local communities.
